RECRUITMENT OF EXECUTIVE TRAINEE (HR), ASST. OFFICER (PR) AND ASST. OFFICER (RAJBHASHA)

Notice

This is in reference to our previous Advertisement reference no. **Advt. No. CC/05/2018 dated 31.07.2018** and our corrigendum ref. no. **Corrig./ Advt. No. CC/05/2018 dated 04th September, 2018**.

1. It has been decided to re-open the online registration window from 01st to 31st October, 2018 for the posts of ET (HR), AOT (PR) and AOT (Rajbhasha).
2. It has also been decided to use scores of English (Paper code 30) in addition to Hindi (paper code 20) of UGC NET July – 2018 and UGC NET Dec-2018 (Both examinations) for the post of **Assistant officer Trainee (Rajbhasha)**.
3. Accordingly, the following candidates shall be considered for shortlisting for the post of Assistant officer Trainee (Rajbhasha) –
 - Who have appeared in the English (Paper code 30) of UGC NET July - 2018 and qualified in the same as per qualifying standards set by UGC NET July - 2018 conducting authority i.e. CBSE (Central Board of Secondary Education). These candidates can apply during above re-opened registration window.
 - Who will appear in the English (Paper code 30) of UGC NET Dec - 2018 and qualify in the same as per qualifying standards set by UGC NET Dec – 2018 conducting authority i.e. NTA (National Testing Agency). **Fresh Registration window** (Fresh registration for candidates as mentioned at sl. No. 01 in our corrigendum ref. no. corrig./ Advt. No. CC/05/2018 dated 04th September, 2018) **and Option window** (option with candidates to choose scores of any examination i.e. UGC NET July-2018 and UGC NET Dec-2018 as mentioned at sl. No. 02 in our corrigendum ref. no. Corrig./ Advt. No. CC/05/2018 dated 04th September, 2018). These candidates can apply during **second registration period** (Tentatively in the month of Jan/Feb'19 i.e. after the declaration of result of UGC NET Dec-2018 examination)
4. For ET (HR) - A single merit list will be prepared from the scores (**as opted by the candidate, details as per our corrigendum ref. no. Corrig./ Advt. No. CC/05/2018 dated 04th September, 2018**) for all candidates who have applied and have appeared in *Labour Welfare/Personal Management/Industrial Relations/Labour & Social Welfare/Human Resource Management (Paper Code-55)* in UGC-NET

(irrespective of whether the UGC NET July-2018 or UGC NET Dec-2018 Exam score is being considered, **as opted by the candidate**).

5. AOT (PR) - A single merit list will be prepared from the scores **(as opted by the candidate, details as per our corrigendum ref. no. Corrig./ Advt. No. CC/05/2018 dated 04th September, 2018)** for all candidates who have applied and have appeared in *Mass Communication and Journalism (Paper Code 63)* in UGC-NET (irrespective of whether the UGC NET July-2018 and UGC NET Dec-2018 Exam score is being considered, **as opted by the candidate**).
6. AOT (Rajbhasha) – Two separate single merit lists (Hindi paper and English paper) shall be prepared as below :-
 - Scores for all candidates who have applied and have appeared in Hindi Paper in UGC-NET 2018 will be merged to arrive at a single merit list (irrespective of whether the UGC NET July-2018 or UGC NET Dec-2018 Exam score is being considered, **as opted by the candidate**).
 - Similarly, for candidates who have applied in English Paper in UGC NET July-2018 and UGC NET Dec-2018 Examination, their scores will be merged to arrive at a single merit list (irrespective of whether the UGC NET July-2018 or UGC NET Dec-2018 Exam is being considered, **as opted by the candidate**).
7. The candidates shall be called (on the basis of above single merit lists) for Group discussion and Interview **(Subject to meeting all criteria as mentioned in our advertisement ref. no. Advt. No. CC/05/2018 dated 31/07/2018 and our corrigendum ref. no. Corrig./Advt./No. CC/05/2018 dated 04th September, 2018)** as below :-

Accordingly, In total 18 candidates will be called from Hindi paper and 17 candidates from English paper will be called for the post of AOT (Rajbhasha). Also, it may be noted that if there are insufficient eligible candidate in either streams who have applied to POSOCO, the candidates from other streams will be called to fulfill the numbers.</i>
