It is to inform that CERC (Sharing of Inter State Transmission Charges and Losses); Regulation, 2010, CERC vide order no. No. L-1/44/2010-CERC dated 30<sup>th</sup> November 2012 had specified the slab Rate for PoC Charges and Losses for October, 2012 - March, 2013.

Slab rate for PoC losses would be based upon the average losses of each region computed from the SEM data of previous week.

The slab rate for POC losses for each region for the period **25 .03.2013 – 31 .03.2013** would be as follows:
