We have such experience but can't submit the Client details or LoA/PO due to Non-Disclosure Agreements (NDA). Hence, we request POSOCO to consider project citation along with a self declaration signed by authorised signatory in our RFP response submission. This is a standard practice adopted by other utilities. We would therefore request POSOCO to give the matter due consideration and accept our request.	copy of Contract / Award Letter and utility certificate /completion certificate/proof of execution to establish the fact that the mentioned contract had been awarded as well as got executed. Any shortfall in such documents submitted in the bid shall be sought through post-bid clarification. In case of NDA, bidder can blacken the confidential sections (bidders name award price, etc.) and submit the documents. If the same is not permitted as per NDA, then the requisite project citation alongwith self-declaration signed by its Power of Attorney holder (authorized signatory of the bid) jointly with Key Managerial Personnel (KMP) of the company i.e. CEO / Managing Director / Company Secretary / Director / CFO / any of the partner in case of partnership firm / any other officer entrusted with substantial powers of the management of the affairs of the company / firm.
