

1. The source of Base case (CTU/ NRLDC/ STU) for carrying out the system study may be mentioned in the procedure itself for all intended studies to be carried out in the interconnection analysis mentioned in clause 6.4 of the ibid procedure.
2. In clause 4.3, STU may be included in the clause, as under -
'Respective RLDC, in consultation with concerned SLDCs, STUs, NLDC and CTU

A new para 5.5 & 5.6 may be added

5.5 While granting Connectivity/GNA the concerned CTUIL/STU would mention the following "Transmission Licensee (s) / Settlement Nodal Agency (SNA) /Generation Entity/ Load Serving Entity / Connectivity Grantee shall furnish the required data in specified formats to NLDC/RLDC/SLDC as applicable on M-7 ("M" is the month of expected first time energization of the new elements) month to carry out Interconnection Studies of New Power System Elements in compliance to clause 10(3) of the Indian Electricity Grid Code, 2023 notified by the Central Electricity Regulatory Commission."

5.6 The LGB for the studies will be taken from TTC/ATC computations file.

Further time lines for data to be furnished to CTUIL/NLDC/RLDC/SLDC and with respect to GNA/Connectivity Procedure, FTC and Inter-Connection Studies of New Power System Elements can be mentioned. (For compliance of Clause 6.6 of Procedure)
