Note: - DNH SLDC (Main) has clarified to do the following and the same have been done above: -

1. NLDC Provisional "National Net SCED Benefits Distribution Statement" for April'22 to June'22 (dated 17.10.2022) had account in name of DD & DNH seprately, the account of these both to be paid to DNHDDPDCL.

The details of statement dated 17.10.20222 are such: DD - Rs. 50,01,056 & DNH - Rs. 36,24,314

Now, the net amount in this respect to DNHDDPDCL will be Rs. 86,25,370.

2. NLDC "National Statement for Net Interest earned on SCED Pool A/c" for FY 19.20, 20-21 & 21-22 (dated 21.03.2023) had account in name of DNHDDPDCL, the amount need to be bifurcated between DNH & DD. The same has been done based on their energy shares from SCED Generators for the respective period.

The details of statement dated 21.03.2023 are such: DNHDDPDCL - Rs. 42,10,689

Now, the bifurcated amount will be of DD: Rs. 12,45,474 & DNH: Rs. 29,65,215

3. NLDC Statement for Final Benefit minus(-) Provisional Benefit for April'22 to Jan'23 (dated 06.02.2024) had account seprately for DD, DNH & DNHDDPDCL, the complete amount of DD & DNH need to transferred to DNHDDPDCL.
