Addendum to Notification of Transmission charges payable by DICs for Billing Month of October, 2023

No: TC/09/2023/A1

Date: 29.09.2023

1. Central Electricity Regulatory Commission (Sharing of Inter-State Transmission Charges and Losses), Regulations 2020 came into force with effect from 1.11.2020. National Load Despatch centre (NLDC) as the Implementing Agency under Sharing Regulations 2020 has been entrusted with the responsibility of computation of ISTS transmission charges and losses. As per Regulation (14)(5)(b), Transmission charges payable by DICs shall be notified by the Implementing Agency by 25th day of the month following billing period.
2. Implementing Agency vide its notification dated 25.09.2023 had notified the transmission charges for the DICs for billing month of October, 2023 in line with Sharing Regulations 2020. Subsequent to the notification it came into notice that CERC vide notification dated 03.08.2023 has notified the effective date of CERC (Sharing of Inter-State Transmission Charges and Losses)(First Amendment), Regulations 2023 i.e. 1st October,2023. Relevant part of the notification is as follows:
 - "a) The Central Electricity Regulatory Commission (Sharing of Inter-State Transmission Charges and Losses) (First Amendment) Regulations,2023 shall come into force with effect from 01.10.2023;*
 - b) The Billing, Collection and disbursement of the inter-State transmission charges and losses for the billing period of October 2023 shall be undertaken in the billing month of December 2023 in accordance with the Principal Regulations as amended by First Amendment Regulations and the process for the subsequent billing period shall be followed accordingly;*
 - c) The Billing, Collection and disbursement of the inter-State transmission charges and losses for the billing period of August 2023 and September 2023 shall be undertaken in the billing months of October 2023 and November 2023 respectively, in accordance with the provisions of the Principal Regulations notified on 01.07.2020."*
3. In view of the implementation of CERC (Sharing of Inter-State Transmission Charges and Losses)(First Amendment), Regulations 2023 with effect from 1.10.2023,T-GNA rates would be required for billing period October,2023.
4. As the T-GNA rates based on the GNA and GNA-RE for October,2023 billing period will be notified on 25th November,2023. Therefore, STOA rates (in Paise/kWh) as notified vide notification dated 25.09.2023 have been converted into T-GNA rates by using the following formula:

T-GNA rate for a State (in Rs./MW/block) =

$$\frac{\text{Transmission charges of the State for the billing month (in Rs.)}}{\text{Number of days in billing period} * 96 * \text{Long Term Access plus Medium term Open Access of the State for corresponding billing period (in MW)}}$$

5. Accordingly, the T-GNA rates applicable for billing period October, 2023 are hereby notified as follows:
- Applicable T-GNA rates for billing period October, 2023 are attached as **Annexure-I**.
 - Rest all other details are same as in the notification dated 25.09.2023.
