विषय/Subject: Time Extension for submission of stakeholder comments/suggestions on Draft detailed procedure covering modalities for first time energization and integration of new or modified power system element

Past reference: NLDC letter dated 25th Aug 2023 to all stakeholders inviting comments/suggestions.

महोदय/महोदया,

In compliance to the stipulations provided in CERC (IEGC) Regulations, 2023, NLDC had published the **Draft Detailed procedure covering modalities for First Time Energization and Integration of new or modified power system elements** in its website on 25th Aug 2023. Comments and suggestions from stakeholders on this draft procedure were invited by 07th Sep 2023. Further, for familiarisation stakeholders with the said procedure, a workshop was conducted in virtual mode on 05th Sep 2023 which was attended by more than 280 participants.

The said draft procedure has been developed by suitably amending the existing NLDC FTC procedure dated 03rd Jun 2020 aligning it with CERC (IEGC) Regulations, 2023 and Report of the Working Group dated July 2022 for RE generators. Further, most of the provisions of the said draft procedure are already in practice other than the testing procedures mandated in IEGC 2023. The said procedure shall be implemented along with IEGC 2023 from its effective date i.e. 01st Oct 2023.

Few stakeholders have requested for extension of time by 2-4 weeks for submission of comments on the said draft procedure. In view of such requests from the stakeholders, the due date for submission of comments and suggestions by stakeholders is being extended till 22nd Sep 2023.
